Thank you for your interest in the City of Austin Employees' Retirement System (COAERS) Retired Member Place 11 Trustee position. To declare yourself as a candidate for the position, complete the enclosed Application and Candidate Disclosure form. *Your completed material must be received on or before* 5:00 p.m. Central Time, September 16, 2022 via email to michelle.mahaini@coaers.org. We have enclosed the COAERS Bylaws and our Code of Ethics for you to keep for reference.

The four-year term of office for Retired Member Place 11 is January 2023 through December 2026. To be eligible to run, you must be a retired member currently receiving a monthly annuity payment from COAERS.

Serving on the Board will require a significant amount of time during your term if elected. We estimate that you will need to devote about fifteen (15) hours of your time a month on a variety of activities:

- Reading materials and preparing for Board and Committee meetings,
- Attending monthly Board of Trustees meetings, generally the fourth Thursday of the month at 10:00 am
- Attending Committee meetings (Trustees are assigned to at least one committee), and
- Attending work sessions and educational programs.

A Candidate's Training Workshop will be scheduled for September (date TBD) to provide candidates with information about serving on the Board of Trustees. Candidates will be given an opportunity to withdraw their application from the election at the conclusion of the workshop if they wish.
