# **Voting Reminder for Retiree Member Place 11**

Retired members should have received a ballot in the mail for the Board Place 11 Retiree Election. Ballots were mailed to retired members in mid-October and must be received back in the COAERS office **no later than 5:00 p.m. on December 3, 2018.** Only retired members of COAERS are eligible to vote in this election. Three related documents were sent in a white envelope with the COAERS logo, including:

- 1. **Ballot**. Vote for **one** candidate on the ballot and then return it. Ballots must be received at COAERS no later than 5:00 p.m. on December 3, 2018.
- 2. Business Reply Envelope. Use this envelope to return your ballot. No postage is necessary.
- 3. **Candidate Statement.** This document contains information about the candidate, his experience and qualifications, and his reason for wanting to serve on the COAERS Board of Trustees.
