This fall, the City of Austin Employees Retirement System (COAERS) is gearing up to hold concurrent elections for Retired Member Place 10 and a special election for Active Member Place 7.

### **Call for Candidates: Active Member Place 7 Special Election**

Are you interested in serving on the COAERS Board? COAERS is seeking candidates for the Active Member Place 7 position.

To be eligible for the Place 7 special election, candidates must be an active member currently contributing to COAERS and not on a leave of absence. For the Place 7 election, please know that members currently employed by Austin Energy and Austin Water cannot run in this election since those departments are currently represented on the COAERS Board of Trustees.

## Election Voting: Retired Member Place 10 and Active Member Place 7

Retirees and active members will have the opportunity to cast their ballots and elect two members to the COAERS Board of Trustees.

Currently, the Place 10 term is set to expire at the end of December 2024. The Place 7 position is seeking candidates following the resignation of Brad Sinclair.

Retired members and active members will have the option to vote through either a mail-in paper ballot or by voting online.

This October, all eligible retired members will receive a paper ballot in the mail, while all eligible active members will receive their ballots in November. COAERS has partnered with YesElections once again to make online voting possible. Online voting information will be located on the paper ballot. Retired and active members who have an email on file with COAERS will also receive election information via email from YesElections with a unique voter identification code and pin.

### **Board News Breakdown**

These highlights are a summary of actions taken and topics discussed by the COAERS Board.

### **Investment Update**

In July, COAERS announced the selection of Meketa Investment Group as its new General Investment Consultant following a comprehensive Request for Proposal (RFP) process. This strategic decision aligns with the System's ongoing commitment to its members to provide their promised benefits through prudent, effective, and best-in-class investment management. COAERS issued the RFP in January due to the pending expiration of outgoing consultant RVK's contract. The rigorous RFP process attracted proposals from several esteemed firms. In collaboration with the COAERS Board and investment staff, Meketa will provide comprehensive investment consulting services, including investment strategy, portfolio analysis, strategic asset allocation, risk management, and performance monitoring.

### **COAERS Funding Policy**

At its September meeting, the COAERS Board approved the retirement system's Funding Policy, which establishes guidelines intended to produce actions to meet the longterm pension obligations promised to all its members.

To achieve this goal, the policy sets forth procedures to pay off any Unfunded Actuarial Accrued Liability (UAAL) over a fixed, closed period and achieve and maintain a funded ratio equal to or greater than 100 percent. The funding policy is intended to be interpreted consistent with the COAERS statute and was jointly developed by the retirement system and the City of Austin. The funding policy is based on the COAERS legislation that passed during the 88th Legislative Session.

### **Benefits 101: Retiree Health Insurance**

City of Austin retirees and surviving dependents of City retirees have access to benefits including basic medical, dental and vision coverage. The retiree health insurance benefit is administered by the City of Austin, not COAERS.

To sign up for health insurance at time of retirement or during the yearly enrollment open period, retirees must the contact City's Human Resources Department Benefits Division. For retirees who elect healthcare



benefits, your share of the premiums are deducted from your monthly pension benefit payment and sent to the City for you. If you have questions about your benefits or need to make changes during the year, please call the City at (512) 974-3284 or visit www.austintexas.gov/retirees.

## Retiree Benefits Open Enrollment Period is Open

Open Enrollment is an opportunity for retired members to make changes to current benefit elections. The City of Austin Benefits team will be conducting in-person enrollment sessions for retirees needing assistance with Open Enrollment changes. These sessions will consist of Benefits staff helping retirees to enroll in benefits and answering benefits related questions.

Retiree Open Enrollment began October 1 and will close on November 1 at midnight. To make changes to your benefits, go to www.benselect.com/coa, or call (888) 584-2919 during the regular business hours of 7 am to 8 pm from Monday through Friday. Spanish speakers are available. For more information on retiree benefits, including a Medicare Advantage video and FAQs, visit www.austintexas.gov/retirees.
